





Year 2017 marked the cooperative's 45th year of rendering reliable electric service to the member-consumer-owners. It was a remarkable year as significant programs and accomplishments have been taken and given significant spot in the cooperatives history.



In utmost dedication and hard work, bringing out their best in providing excellent service, the Board of Directors, Management and Staff of ISELCO-I, are committed in providing excellent service which benefits the people they serve.

With this commitment, the cooperative was once again awarded by the National Electrification Administration (NEA) as Triple A Mega Large Cooperative, the highest rating given to a distribution utility as a manifestation of the coop's good financial, institutional and technical operations awarded during the Lumens Awards on April 28, 2017. Furthermore, Model Headquarters Facilities Award was also awarded to ISELCO-I in its effort to enhance the EC corporate image by providing state-of-the-art headquarters facilities with well-maintained workplace and surroundings which promotes employees' high level of productivity.

ISELCO-I is not only committed to serve its MCOs but is also committed to its partner corporations in which one way or the other helps in the cooperative's growth and success. With this excellent commitment, ISELCO-I hails among others and awarded as Prompt Payor Distribution Utility by the San Miguel Energy Corporation (SMEC) for consistently realizing the set prompt payment deadline.

With this, the cooperative was able to save a total of Php76,813,675.86 in availing the Collection Efficiency and Prompt Payment Discounts. Half of this is being redounded to the member-consumer-owners through rate reduction to recompense their cooperation in paying their bills on time. The resilient financial standing of the cooperative corresponds to a lower power rate, reason why ISELCO-I has the lowest power rate among neighboring electric cooperatives.

With its pledge towards the realization of its mandate of bringing light to the Filipino people through total rural electrification by supporting the Sitio Electrification Program (SEP), the cooperative was able to energized 33 Sitios benefiting 720 households who are now enjoying the benefits of electricity.

INSTITUTIONAL SERVICES DEPARTMENT

Committed to fortify both the cooperative's workforce and Member-Consumer-Owners (MCOs), the Institutional Services Department (ISD) being at the frontline of ISELCO-I, did its fare share in completing the target goals of the cooperative for the year 2017. Hence, the following are the accomplishments carried out through the concerted effort of the ISD personnel.

Member-Consumer-Owners' empowerment was one of the highlights of the year as mandated by the National Electrification Administration (NEA) resulting to the organization of MCOs in the grassroots level. This is particularly in line with the 3rd point agenda of NEA which seeks to prioritize empowerment programs for the electric consumers to become strategic partners in crafting and establishing programs & projects which are beneficial to the cooperative and community as a whole.

For the year, the cooperative through the active involvement of the ISD and Board of Directors has organized 2 cities (Santiago City & Cauayan City), 7 municipalities (Angadanan, San Guillermo, Cordon, San Mateo, San Isidro, Reina Mercedes, Jones), 117 barangays and 2 special sectors namely Isabela Green Ladies Organization and Indigenous Peoples (IPs).



On August 7, 2017, an oath-taking of the Federated MCOs was held at ISELCO-I Headquarters which was administered by the Vice-President of the Board of Directors, Directors of the seven (7) Districts after a successful conduct of the 2017 District Elections. Dir. Brendon R. Lazaro.



Empowered MCOs means empowered cooperative that is why ISELCO-I is fervent is delivering accurate and reliable information to member-consumer-owners through information drives in various barangays as well as assembly meetings in the barangay and municipal levels. This endeavor has intensified the coop's information campaign through the use of media in order to reach even the farthest sitios of ISELCO-I.

Prior to elections, thorough preparations were executed by the department personnel such as sanitation of membership master lists, proper coordination with Local Government Units & other institutions, likewise, preparation of election paraphernalia just to name a few.

To keep the employees abreast and updated with the incessant development and changes taking place in a wider scenario not only in the electrification industry but also in the human resource industry various seminars and trainings were conducted. On May 22, 2017, an Employees Compensation Commission (ECC) Orientation-Seminar facilitated by Ms. Remedios V. Andrada, Information Office II of the ECC Regional Extension Unit (REU) Region II, was held during the coop's Monday forum.

Employees' safety is always at the top goal of the coop's business operations, hence, the Nationa Grid Corporation of the Philippines (NGCP) spearheaded an Electrical Safety Training Seminar on Jung 28-29, 2017. With the objective to inform participants about the hazards of performing daily tasks a well as the safety practices needed, electrical engineers, line foremen, linemen and Power Us Coordinators (PUCs) completed the 2-day seminar.







Moreover, adding value to its workforce is a customary duty of the cooperative. On August 24-25, 2017, a Basic Life Support Training in partnership with the Southern Isabela District Hospital through the coop physician, Dr. Rhea Cez Javier, had transpired.



The National Electrification Administration has been a resolute partner of ISELCO-I in holding seminars and trainings. The cooperative hosted all electric cooperatives in Region 2 and Cordillera Administrative Region (CAR) for the Warehousing Seminar and Working Procedures on September 19-22, 2017, followed by a Net Metering Seminar and Renewable Energy Seminar on October 19-20, 2017.



ISD also initiated a seminar-workshop on Grievance Machinery Handling in collaboration

with the National Coalition & Mediation Board through the Resource Speaker, Mr. Olisen L. Dizon, Senior Labor and Employment Officer. This has allowed employees of the cooperative to be equipped in handling and minimizing grievances.



ISELCO-I is keen in upholding its Corporate Social Responsibility; the annual distribution of donations in kinds and goods to MCO beneficiary never loses its momentum. With this, a Bingo Rama fund raising for Outreach Program transpired. The benevolence and cooperation of the employees paved way to the fruitful realization of the program. 



In order to provide reasonable assurance regarding the achievement of coop objectives relating to operations, reporting and compliance the Internal Audit Department continuously the cooperative was never left behind. performs the audit cycle, including risk management and control management over operation' effectiveness, financial reliability and compliance with policies and regulations.

During the year 2017, the department prepared and presented audit findings and recommendations to make improvements to operations. The department also assessed how well risk management processes are working and how well the coop is complying with rule. and regulations and informing management of any issues that need addressing.

The financial audit division provided additional oversight to internal accounting practices. To ensure that there is oversight, internal control such as segregation of duties is properly practiced to minimize error and prevent fraud. To add credibility to the reported financial position and performance the division validates the recording of day to day transactions specifically on collections and disbursements. The financial auditors periodically examine the coop's financial records to ensure they are accurate and up-to-date and that process for generating and maintaining financial records and documents comply with applicable rules and standards.

On the other hand, the operational audit division focused on the review and assessmen of various business processes, procedures and systems to improve the efficiency and effectiveness of ISELCO-I's day-to-day operations. Through the combined efforts of the team the department unceasingly ensures the effective implementation of coop's policies and hastened and improved. guidelines as well as the adherence to different regulatory agencies. 

Report on the Audit of the Financial Statements

Opinion







UPGRADING DISTRIBUTION NETWORK SYSTEM


SCADA (Supervisory Control and Data Acquisition) System


Nowadays, computer control is one of the most cost effective solutions for improving reliability, optimum operation, intelligent control and protection of a power system network. Having advanced data collection capabilities, SCADA system plays a significant role in power system operation. Basically, at the distribution side SCADA does more than simply collecting data by automating entire distribution network and facilitating remote monitoring, coordinate, control and operating distribution components as a Smart Grid System.

Recently, we've already started upgrading our communication system by installing Fibe Optic Cables in our coverage areas. These fiber optics are capable of transmitting large amounts of data at very high speed.

By evaluating the benefits and advantages delivered to us by the SCADA technology the plan to implement it in our other substations was already made possible. As of now, four of our substations (BATAL, CORDON, SAN FERMIN, and DISTRICT 1) are currently being monitored and controlled using SCADA System.







UPGRADING OF SUBSTATIONS / DISTRIBUTION LINES

Last year, 2017, as the newly constructed 20 MVA substation in San Fermin, Cauayan City was fully energized, ISELCO-I also started on the uprating of its substation's transformer at Malapat, Cordon; from a 10 MVA to a brand new 20 MVA transformer. This is to satiate the continuous load growth of the area as well as to prevent the shortage of power. Now it is supplying enough power to the southern part of the coverage area. Moreover, the distribution lines, equipment and poles are being upgraded in order to deliver a safer and more reliable electricity.

Furthermore, the department have planned to construct a new 10 MVA substation at Garit Sur, Echague and will be fully energized by 2018. This substation was planned to improve the reliability of electric service distribution and to sustain the unpredictable load growth to that area.







ARTICLE II - ELIGIBILITY TO RUN AND CERTIFICATE OF CANDIDACY

Section 7. Qualifications of a Director and an Officer. -

Pursuant to Section 26-B PD 269, as amended by R.A. 10531, a candidate's integrity, experience, education, competence and probity shall be considered in determining whether he/she shall be fit and proper as a director or an officer of the EC. The following shall be the minimum qualifications, thus:

- 7.1. He or she is a Filipino citizen;
- 7.2. He or she is a graduate of a four (4) year course;
- 7.3. He or she should be between twenty-one (21) years old and seventy (70) years old on the date of election;
- 7.4. He or she is of good moral character, which may be established with the submission of a clearance or certificate from any of the following:
 - 7.4.1. Barangay where the candidate resides;
 - 7.4.2. National Bureau of Investigation;
 - 7.4.3. Philippine National Police; or
 - 7.4.4. Leader of the religious sect where the candidate is affiliated.
 - 7.5. He or she is a member of the EC in good standing. A member of good standing shall mean that said member: has no unsettled or outstanding obligations to the EC whether personal or through commercial or industrial connections of which he or she is the owner/co-owner three (3) months prior to the time of filing of certificate of candidacy: Provided, that for the incumbent members of the EC Board who will seek re-election, unsettled or outstanding obligation shall be deemed to include power bills, cash advances, disallowances (including NEA audit findings) and materials and equipment issuances reckoned from the time of filing of certificate of candidacy as stated in the (DOE -Department Circular no. DC2014-09-0017).
 - 7.6. Has not been apprehended for electric pilferage;

of electric pilferage by the EC, even without A mere apprehension conviction for such offense by any court, shall constitute a valid ground for disqualification. The word "apprehension" should be taken in the strict context as used in Republic Act No. 7832, otherwise known as "Anti-Electricity and Electric Transmission Lines or Materials Pilferages Act of 1994", which means that a person is caught in flagrante delicto for violating the provision of the said act.

In general, removal or termination of service from the EC is caused by a grave offence or violation/s of policies, rules and regulations. A former director or employee with a record of termination/removal for cause from public office or for just cause as defined in Article 282 of the Labor Code as amended, shall not be qualified to be elected or appointed as director of an EC.

- 7.8. He or she is an actual resident and member-consumers in the district that he or she seeks to represent for at least two (2) years immediately preceding the election; and
- 7.9. He or she has attended of at least two (2) Annual General Membership Assemblies (AGMA) for the last five (5) years immediately preceding the election or appointment.
- 7.10. For a qualified government employee, he/she must present a written Certification from his/her Department Secretary/Regional Director/Local Chief Executive or his duly authorized representative allowing him/her to run and sit as director at the time of his/her filing of Certificate of Candidacy.
- 7.11. An EC Director or Officer, in order to remain as such must continue to possess all the qualifications and none of the disqualifications throughout his/her term or tenure of office. To this end, no EC Director shall be allowed to stay on a hold-over capacity if he/she fails to meet all the qualifications or is deemed disqualified.

Section 8. Disqualification of a Director and Officer. -

Pursuant to Section 26-B of PD 269, as amended by R. A. 10531, any person shall be ineligible to be elected or be appointed as member of the Board of Directors or Officers of an EC if:

- 8.1. Such person or his or her spouse holds any public office. For the purpose of disqualification, a person holding an elective position or an appointive position with a salary grade of sixteen (SG 16) or higher or its equivalent shall not be eligible to be elected as member of a Board of Directors or officers of an EC;
- 8.2. Such person or his or her spouse has been a Candidate in the last preceding local or national elections;
- 8.3. Such person has been convicted by final judgment of a crime involving moral turpitude;
- 8.4. Such person has been terminated from public office/ government employment or

- private employment for just cause as defined in Article 282 of the Labor Code; For this purpose; termination from public office shall mean removal;
- 8.5. Such person is related within the fourth civil degree of consanguinity or affinity to any member of the EC Board of Directors, General Manager, Department Manager, NEA-appointment Project Supervisor (PS) or Acting General Manager (AGM) and its equivalent or higher position;
- 8.6. Such person is employed by or has financial interest in a competing enterprise or a business selling electric energy or electrical hardware to the cooperative or doing business with the EC including, but not limited to, the use or rental of poles;

 For this purpose, "doing business" shall refer to the transactions related not only

For this purpose, "doing business" shall refer to the transactions related not only to the core or main line of business of the EC, but also those which in any way affect the management and operation of the EC.

- 8.7. Incumbent GM and employees of electric cooperatives are not allowed to run as member of the board of another cooperative; and
- 8.8. The disqualification of one of the spouse shall mean the disqualification of the other.
